

# MARK YOUR CALENDAR FOR THE MAGIC CASTLE SWAP MEET

## SATURDAY - October 9, 2010

**BUYERS: Magician members, spouses or significant others will be allowed in at 9:00 a.m.**

Non-members can gain entrance by paying a \$8.00 "Non-member Entrance Fee" at the door.

**SELLERS: NO ADMITTANCE BEFORE. 8 A.M.** - Magic and magic related items ONLY are to be sold!

1. Vendors begin set-up at 8:00 a.m. Buyers enter the Swap Meet at 9:00 a.m. **VENDOR AND VENDOR'S GUEST BADGES MUST BE WORN FROM 8 a.m. to 9 a.m.**
2. Assigned tables are subject to availability at the Magic Castle. A standard single table can be 3'x4', although the use of all tables available will be utilized to create a multiple table set-up. Since the Magic Castle has a limited amount of space, it is necessary to limit the size of the tables we use. Tables from the dining area and specially constructed tables (3'x4' in size) are used throughout the Magic Castle for each vendor. The table fees are listed below.
3. Assigned tables must be set by 9 a.m. If the seller does not occupy the table by 10 a.m. the table will be reallocated, or removed (unless there are special circumstances).
4. It is the desire that at each Swap Meet all Members have the opportunity to participate at the event. We have limited the number of tables available for use for this purpose. Three tables are the maximum number of tables allowed per vendor. **It is important to reserve your table(s) early. Complete the application as soon as you can. Once the allotted tables have been reserved, any remaining applications and fees will be returned. As always, first come first served!**
5. The application for the Swap Meet is Non -Transferable for your table(s). This insures each Vendor has a **Resale Number. Completed Occasional Seller request and BOE 410-D** listed with the Magic Castle for each swap meet. All Vendors who are required to have a Seller's Permit are responsible for all sales at your table(s). It is your responsibility to contact the Swap Meet Coordinator if you do not intend to use your table(s).
6. There is a limited amount of space for Illusions to be displayed (area subject to availability). **\*\*Indicate if you are selling illusions under "REQUIREMENTS"**.
7. The use of P.A. systems, audio equipment or other sound devices are not allowed during the Swap Meet by Vendors. Please bring your own extension cords as necessary. The use of a monitor for video playback is allowed, but please keep the volume off at all times as a courtesy to the other vendors. All questions will be resolved by the Swap Meet Coordinator at the event.

**IT IS THE RESPONSIBILITY OF EACH VENDOR TO HAVE A VALID SELLER'S PERMIT AND A COPY OF THE BOE 410-D AVAILABLE UPON REQUEST AT THE SWAP MEET. It is necessary for a completed application with either a resale certificate AND a BOE 410-D to be on record at the Magic Castle for each swap meet.** You can obtain the form BOE 410-D or a one day permit at **NO COST** at your local State Board of Equalization (check your telephone book or [www.boe.ca.gov](http://www.boe.ca.gov)). Required Vendors will not be permitted to participate on this day without this permit or form on record at the Magic Castle Office. **As always, first come first served! The deadline date is in effect unless all tables are reserved prior to April 1st! Don't hesitate to MAIL your application in as soon as possible.**
